UTILISATION OF SERVICES OF TSEWA AND ALLOTMENT OF OFFICE SPACE AT INCS FOR THE BENEFIT OF VETERANS OF TRISERVICES AND VEER NARIS

Dear Sir,

- 1. Tri Services Ex- Servicemen Welfare Association (TSEWA) is a Registered apolitical welfare organisation with its Headquarters in Secunderabad as per the details given above. The organisation is an Apex National Welfare organisation for Ex-Servicemen and War Widows with more than 6000 ex-servicemen as Members from all the States in India. Unlike most of the Ex-Servicemen Organisations which either indulge in politics or just while away the resources and time on costly entertainment, TSEWA believes in "True Sewa" to the Ex-Servicemen especially JCO/OR and their equivalents in the Navy and the Air Force.
- 2. TSEWA is self funded by its Members through voluntary contributions and Executive Committee Members travel the length and breadth of the country to interact with the Ex-Servicemen, Single Ladies and Veer Naris. A typical presentation covers all aspects of Pensions, entitlements, Rule Position, Present anomalies in various Pay Commissions, Court Judgements including those of AFTs, benefits accruing out of court Judgements, ECHS, CSD entitlements etc. The post lunch session is utilised for personal interaction on the lines of "Pension Adalats" and necessary letters are written to the record offices, PCDAs, CPPCs and PDA banks where ever the pensions are not correctly fixed or not paid including the rightful entitlements. The travel, venue arrangements, Lunch, Refreshments cost the organisation a handsome amount but volunteer Members generously donate for the good cause.
- 3. TSEWA thanks the Eastern Naval Command, Visakhapatnam for giving us the opportunity to address the VSF Members on 20 Nov 2016 and conduct "Pension Adalat" post lunch on the same day. A large number of VSF benefitted from our presentation and interaction. TSEWA would however like to submit to the Chief Of Staff, ENC that as per the estimates, there are more than 14,000 to 15,000 Ex-Servicemen attached to the INCS and the ECHS. There is no official mechanism to redress

their grievances and resolve their pension related problems in the Command other than CRSO Organisation which caters only to the VSF.

- 4. The Chief of Staff is aware that 14 Jan is now accepted as the Tri Services Veterans Day and the First Veterans Day is likely to be celebrated on 14 Jan 2017. TSEWA volunteers to conduct a full day workshop during the occasion including a "Pension Adalat" on the Day as was done on 20 Nov 2016 for the VSF. Since it may not be possible for TSEWA to attend to such a large population of Ex-Servicemen of the Tri Services, TSEWA also proposes to open a small office to facilitate regular interaction for Redressal of the grievances. If such an office is co-located near INCS, it is considered that the veterans, Single Ladies and Veer Naris will be able to resolve their pension related matters when they visit the canteen. The President of TSEWA of Andhra Pradesh who is located in Visakhapatnam will man such an office with his skeletal staff and volunteers.
- 5. In view of the above, we request the Chief of Staff of the Eastern Naval Command for the following:
 - (a) Permit TSEWA to make a presentation to the Veterans of Tri Services on the Veterans Day likely to be celebrated on 14 Jan 2017
 - (b) Kindly allot a small office near the INCS to establish grievance Redressal system for the Veterans of the Tri Services on the lines of CRSO of the Command. The office could be named as "TRI SERVICES VETERANS WELFARE OFFICE" which could be inaugurated on 14 Jan 2017 to coincide with the
