Sir,

1. Vide ibid order dated 30.08.2016 the Hon'ble AFT
(PB) New Delhi has allowed the OA by granting
broad banding of the disability pension to
nearest, @50% or 75% by "rounding off" the
existing disability/war injury pension w.e.f. the
date of their retirement/discharge.
2. All the Applicants are entitled for arrears of
the "rounding off" of disability pension/war

injury pension for the last 3 years preceding the date of filing of the OA i.e. 05.12.2016 or the date of their superannuation/discharge whichever is later alongwith interest thereat @8% per annum on the entire arrears till the date of actual payment, in each case as relevant, if order is not complied within four months from the date of receipt of a copy of the order.

3. Copy of the court order is attached as Appendix 'A' to this letter for ready reference please, which needs to be implemented/ effected within 4 months from the date of receipt of the copy of this order.
4. The list of the Applicants from Army/Navy/Air Force is attached as Appendix 'B' to this letter.
5. Submitted for expeditious implementation of the judgment by issuing a revised PPO and release of arrears. Alongwith interest at an early date if you have not implemented the order within 4 months from the date of receipt of a copy of this order.
