1. The President welcomed all to the meeting. The General Secretary thereafter gave an update on the points of the last meeting held on 27th Jan 2024.

a) **Progress on Court Cases:** The General Secretary gave the following points: -

i. Maj Gen and Equivalent case in AFT: A total of 55 officers have submitted their documents, out of which the first batch of 27 Army officers' cases has been sent to our advocate Col Indra Sen Singh, and the case is filed with OA 409/2024.

ii. **MSP-MG case in Delhi High Court:** A total of 66 applications have been received, along with documents. The same is being compiled and will be forwarded on 4th March 2024 to our Legal Advocate Brig AK Srivastava, for filing the case in the Delhi High Court.

iii. A detailed update on the progress of the rest of the cases already filed in AFT Delhi is available on our website.

b) **Annual Donation to TSEWA:** The General Secretary informed that as on date i.e., 1st March 2024, a total sum of Rs. 21,71,421/- (Rupees Twenty-one Lakhs,

seventy-one thousand four hundred twenty-one only) has been received from 190 TSEWA members. The consolidated list is being updated on our website every Saturday.

2. **Points from the President:** The President TSEWA, Brig CS Vidyasagar gave the following points:

a. Awareness Camp/ Workshop in East Zone: The President informed all that Maj Gen Shibnath Mukherjee (President East Zone), and his team had organized two awareness camps Viz 10th Feb in Kolkata and 11th Feb in Durgapur. Both the events were meticulously planned and well organized. A very large number of ESM and Veernaris attended the camps, Overall, it was a grand success.

b. The chief guest for the event at Kolkata was ACM Raja, he expressed his appreciation for the excellent work being done by TSEWA for the benefit of ESM and Veernaris.

f. Visit to Kochi: The President informed that he is Scheduled to visit Kochi (Kerala) from 24th to 26th Feb to conduct a Workshop/ Seminar for the DSSLOG of Kerala.
