a) **Progress on Court Cases:**

- i. **Maj Gen and Equivalent case in Delhi High Court:** The General Secretary informed that all documents were forwarded to our Legal Advocate Brig A K Srivastava,VSM, and received by him except for one affidavit in respect of Maj Gen Ravindra Singh. The same has been dispatched by HQ TSEWA to Brig AK Srivastava and the case will be filed in the Delhi High Court shortly.
- ii. **Hony Nb Sub Case:** A court verdict has been given. The gist of the verdict will be informed by Brig AK Srivastava shortly.
- iii. **Maj Gen Case in AFT:** This case is being represented by our Legal Advocate Col Indra Sen Singh in AFT Delhi. The case has been listed for hearing on 15th April 2024.

- b) **Annual Donation to TSEWA:** The General Secretary informed that the total donation received so far from 287 members is Rs.31 Lakhs.
