been closed without remitting the arrears of old age
pension for three months (Aug to Oct 2023).

His last two complaints **No 1010157597 dated 02
Jan 2024** was CLOSED on **08n April 2024** after

sparsh was showing **"IN PROGRESS" for 97 days**.The second complaint **No 1010866551 dated 15 Mar 24** was also **CLOSED on 08 April 2024 after showing "IN PROGRESS" for 24 days**.His SPARSH account is showing these 2 complaints as **PROCESSED**,but it does not show what action is taken on his complaints or when SPARSH will pay his dues, even after 20 days of closing the complaints?

5. It is requested to remit the old age pension for the months of Aug to Oct 2023 without any further delay. As per RBI guidelines on delayed payments, all CPPCs are supposed to pay 8% penal interest for delayed payment vide their master circular of Apr 2023. SPARSH being a CPPC is also duty bound to remit 8% penal interest for the delayed payment of arrears of old age pension.
