	<u>Overpayment of Pension Even After Death of Husband</u>	
1	<p>1. Mrs Pritipal Gill is married to Commander RBS Gill. The date of birth of the officer is 27 Oct 1956. He put in 21 years of service in the Navy. Unfortunately, he passed away on 31 Aug 2020. Age at the time of death of the officer is 44+19=63 years, 27 days (Copy of E-PPO issued by PCDA (Navy) Mumbai is attached).</p> <p>2. Mrs Pritipal Gill was sanctioned Enhanced Rate of Ordinary Family Pension (ER-OFP) till her husband's age is either 67 years (27 Oct 1956 + 67 = 26 Oct 2023) or 7 years from date of death (31 Aug 2020+7 years = 30 Aug 2020). Thus she was sanctioned ER-OFP till 26 Oct 2023 being earlier of the two dates. From 27 Oct 2023 she should be paid only Ordinary Family Pension which is 60% of the pension of her husband.</p> <p>3. But she is being paid ER-OFP till date which results in overpayment.</p> <p><u>Grievance.</u></p>	<p>Grievance is at the final stage of redressal.</p> <p>The documents were handed over to PO Vaibhav Rai of Navy Pension Liaison cell on 14 May 2024.</p> <p>Cdr Dhruv Tiwari was not in the office on 14 & 15 May 2024</p>

	<p>4. SPARSH is requested to remit only Ordinary Family Pension (81250×0.60) +DR = Rs 48,750+DR) from 27 Oct 2023 and work out over payment ($81250 - 48750 =$ Rs 32,500 + DR) made till date. The overpayment be recovered not more than one third of her Ordinary Family Pension.</p> <p>5. Detailed calculations for number of months required to recover over payment is given in MS Excel sheet (Attached)</p>

He approached Bureau of Sailor, Mankhurd, Mumbai-400088 who in turn informed that the Naval Records have been updated with change of name to the new name.</p> <p>3. PCDA (Navy) Mumbai consequent to 7th CPC did not issue him E-PPO. When he approached PCDA(Navy), Mumbai they informed me that his account was migrated to SPARSH and hence EPPO is not required. 2. He on logging into SPARSH found that he was migrated and his legacy PPO No : 997 A S000 1122003 is now available with SPARSH and his future monthly pension will be remitted into his bank account. But he found that his account was marked as discrepant due to basic data missing (copy of screen shot is attached). His was not able to access his account in SPARSH for quite some time. After complaining, it is now accessible. 3.
