# Minutes of the Virtual/ Physical Meeting of the TSEWA National Executive Committee held at 1000 Hrs. on 18 Oct 2025

- **1. The Vice President** welcomed all to the meeting. The General Secretary thereafter gave an update on the progress of the points raised in the last meeting held on 20 Sep 2025.
- a. **Smt. Shalini Gupta, Joint Secretary:** Mrs. Shalini Gupta informed that in the case of Smt. Suman Sharma, the PPO has been obtained and forwarded to PCDA Prayagraj, and a response from PCDA is awaited. She further informed that Smt. Suman Sharma has met a lawyer who has agreed to assist her in the matter. Additionally, Smt. Suman Sharma visited the Naval authorities in Chennai to pursue her case and seek necessary support for early resolution.
- b. <u>Progress on Recognition (PWA):</u> The Ministry of Defence (Pensions and Grievances) has issued a letter regarding membership in the Pensioners Welfare Association (PWA). Member details have been entered on the designated website for the generation of the DARPAN ID, and information on activities and achievements has been

uploaded accordingly. The application is presently awaiting approval for the issuance of the DARPAN ID to enable further processing.

# 2. The General Secretary then gave the following points:

## **Charity Work at TSEWA**

- a) ESM Naik M. Pandu (ASC) visited the office of TSEWA with a request for financial assistance for enhancing his mobility, as his leg was amputated.
  - As an immediate relief, one wheelchair was released. Further, his case was taken up with ZSWO Hyderabad for processing the case with Army HQ.
- b) Miss B. Rajini, who was being assisted to pursue her academic qualification (MBA), put up an additional request for a computer course. An amount of Rs. 30,000/- was immediately released to meet the deadline for fees. Concurrence of NEC members was obtained.
- c) Mr. Prashan Chhetri, a student pursuing B.Sc. Maths and Computer Science at St. Joseph University, requested financial assistance from TSEWA to meet his educational expenses. Based on his request, an amount of ₹20,000/- was transferred to his account by TSEWA towards educational support. He has confirmed the receipt of the amount and expressed his sincere gratitude for the assistance extended by TSEWA.

#### 3. Points from Members

- 1. Maj Gen Shibnath Mukherjee, President East Zone: Gen S. Mukherjee gave an update on the awareness camp to be conducted in and around Kolkata from 31<sup>st</sup> Dec 2025 to 2nd Feb 2026. Planned locations were Kolkata and Durgapur (subject to approval, since the time taken to and fro Durgapur is over 4 hours). Further, alternate venues will also be surveyed in case the planned venues are unavailable. TSEWA is asked to confirm the list of attendees from HQ TSEWA.
  - The Vice President requested President East Zone to forward the approximate expenditure involved in the conduct of the awareness camp.

### 2. Smt. Shalini Gupta, Joint Secretary:

i) Miss Ruchie is the daughter of an Army officer: Her mother is in receipt of LFP, she has remarried and settled in Canada, but has refused to provide NOC for the daughter to get her share. Col Ajit Rana conveyed that prolonged delay may facilitate suo moto action by the administrative authorities to allot a pro-rata share to the widowed/divorced/dependent daughter. Col Vinay Sharma would liaise with MP5 during his next visit.
