2. Legal Fees and Refund:

Once the case is filed/registered before the Hon'ble Court (AFT/High Court/Supreme Court), the legal fees paid by the applicant will be **non-refundable**.

If, for any reason, the case is not filed, or the applicant withdraws before filing, the amount paid will be refunded after deducting 10% of the total legal fees towards clerical, administrative, documentation, and processing expenses.

3. Court Proceedings and Outcome:

The progress of the case, including listing, hearings, adjournments, time taken for disposal, interim orders, and final judgment, is entirely dependent on the Hon'ble Court. These matters are beyond the control of TSEWA and its legal representatives.

Therefore, TSEWA or its legal representatives shall not be held responsible for any delay in the proceedings or for the outcome/decision of the Hon'ble Court.
